#### THE PANEL EXPERTS



Marie de Hemricourt Judge at the Council for Alien Law and Litigation, Belgium

Marie de Hemricourt has been working in the field of asylum since September 1995, first as a jurist at the Belgian General Commission for Refugees and Stateless (Commissariat Général aux Réfugiés et aux Apatrides - CGRA), the Belgian administrative authority in charge of examining asylum applications, and then, since January 2005, as an assessor at the Permanent Refugee Appeals Board (Commission Permanente de Recours pour les Réfugiés - CPRR), an appeal body for refugees which was replaced on 1 June 2007 by the Aliens Law and Litigation Council (CCE). She has participated in several EUAA activities in the past, including the relevant to the present panel roundtable held in Paris in March 2022, which focused on assessing the credibility of claims based on sexual orientation.

John is an experienced barrister, with expertise in international protection law, immigration law, EU law, citizenship law, human rights law, and public administrative law. He has advised the Irish State and individual applicants in many cases involving international protection and human rights. As Deputy Chairperson of the International Protection Appeals Tribunal, he was part of the Tribunal's senior management team, heard and decided appeals, and trained, coached and mentored other decision makers. He was also previously Chairperson of the Irish Refugee Council. As Advisory Counsel at the Office of the Attorney General, he directs State litigation in asylum law as well as other areas and advises on legislation and policy. He is the writer of Immigration and Citizenship Law (Round Hall, Dublin, 2017), the leading Irish legal text on immigration law, and has written widely on related matters. He has worked for the International Association of Refugee and Migration Law Judges and provides training on international protection law on behalf of the European Asylum Support Office. He lectures at both Dublin's Honourable Society of Kings Inns and the Law Society of Ireland.

Chelvan is a UK-based barrister with expertise in international protection claims and LGBT+ rights. He has provided training to Judges, lawyers, NGOs, activists and those seeking-asylum. He litigates from First-instance Tribunals to the Supreme Court, and the European Court of Human Rights. Chelvan has been instructed as sole or leading Counsel on various cases dealing with LGBT+ protection claims since 2001, including the Country Guidance cases of DW (Jamaica) in 2005, JM (Uganda) in 2008, SW (Jamaica) in 2011 and BF (Albania) in 2019. He joined 33 Bedford Row Chambers in November 2020 as Head of Immigration and Public Law. From September 2022, Chelvan joined the University of Southampton as a Visiting Adjunct Professor at the Law School's Research Centre for International Law and Globalisation. In 2011, Chelvan created the Difference, Stigma, Shame and Harm model ('the DSSH model') as a positive tool in the credibility assessment of LGBTQ+ refugee claims. UNHCR and EASO endorsed and have used the model in fieldwork training since 2012, the UK Home Office since 2015, and the International Association for Refugee Law Judges included the model in their 2018 Handbook. Chelvan has provided training on the model to various European and global refugee status determination bodies. He has received multiple awards in recognition of his extensive work in SOGIE international protection claims.
